# Public Comment:

- Barry Moore of 69 Green Street indicated there was an issue with runoff on Green Street. Water jumps the curb and floods his yard and has created a sink hole. Neighbor, Alan Johnson had problems with flooding in the basement. Chad indicated that this was being investigated by VLCT and noted that the entire street needed a new storm system.
- Joanne Bunnell of River Road indicated that cars at 33 Lewis Court were parking and causing safety concerns on River Road.
- Al Dunn indicated the Selectboard should continue to work on sidewalks, lighting, housing and tax stabilization.

- Dennis asked about the Highway fund and Lesley indicated there would likely be a small deficit which could be absorbed in the unallocated reserves.

- The Town received a Merit Award from the American Council of Engineering Companies for the Green Infrastructure associated with the Oak Street Infrastructure Project.
- Andrew Buckley, the new Fire Marshall had started and would be attending a future meeting to meet the board and discuss the Code Compliance Program.
- Dennis and Chad had visited Goss Hollow following the inquery by Lonnie Waterman. They noted the gravel he saw over the bank and the apparent erosion. Suggested that road width should be looked at in this area, and likely other areas around Town. Chad would be following up with DPW.
- Portland Street Scoping Study proposals have been received and are under review by the Bicycle Pedestrian Committee.
- The Railroad Street and South Main Street project is advertised to bid.

## Other Business:

- Kevin asked the clerk if there was any progress on dog licensing and Stacy indicated that the Community Restorative Justice Center was making follow up calls.
- Jo Brahman asked there were requirements for landlords to provide trash and recycling services and Kevin indicated it was between the landlord and the tenant.
- Stacy Jewell indicted that the appraisal notices have been sent out and people have 14 days to respond.
- Jim Brown indicated there was some sidewalk damage on the property behind the car wash on Pearl Street.
