2022/2023 Proposed Budget

- Chad Whitehead reviewed the Draft Budget
- Kevin opened the meeting to questions and comments.
- Brendan asked if the board had considered separating the Fire Department Budget from the General Fund. Kevin noted that that had been considered previously but the board had not chosen to separate the funds.

Charter Amendment- Warning of First Public Meeting:

• On a motion by Dennis and second by Frank the board approved the Warning of the Charter Amendment Public Meetings.

Easement Request- 10 Eastern Avenue

- Brad Ashley and Bob Duncan addressed the select board to request an easement for the
 installation of a ventilation system to allow the northern most space in the New Avenue
 Commercial Space to be used as a restaurant. This was still under review by the
 Development Review Board. This would result in the loss of up to 3 parking spaces
 adjacent to the building.
- On a motion by Dennis and second by Brendan the board authorized the Town Manager to execute an easement with the New Avenue Commercial Space. Frank abstained.

Armory Update:

- Joe Kasprzak provided an update to the Select Board regarding the Armory Project.
- The Manager's office has reviewed Architectural proposals and is currently negotiating a contract and expects to bring the design contract to the Select Board at the first meeting in January. Contract is set up so that the Town can delay or stop work with minimal notice to reduce risk.
- Proposals have been received for the Qualified Environmental Professional and were under review.
- The Town is eligible for EPA Brownfield Assessment Funds to complete the Corrective Action Plan and is submitting an application to the program.
- Joe asked if the Board would be ok with Monthly updates regarding the Armory and the board agreed.

Manager's Report:

- Chad Whitehead reported that the Town has completed interviews with Fire Chief applicants and anticipates an announcement to be made the first week of January.
- Setting time for ARPA meeting near the end of January.
- First Night in person event has been moved online due to COVID.

Other Business:

Police and Dispatch Collective Bargaining Agreement:
