Town Manager's Report:

• Chad Whitehead, Town Manager provided the following Town Manager's Report.

- DPW is in plowing mode with the recent storms however they also continue to work on completing the stone line on Spaulding Hill Road.
- Construction continues on the Water Plant.
- The furnace at the DPW Garage needs to be replaced. Steve Beauregard is working on obtaining quotes and identifying funds.
- DPW is fully staffed at this point.
- A badge pinning for FF Jedlick will be held tomorrow at 4:30 PM at the Fire Department.
- St. Johnsbury has acquired a loaner fire truck from Littleton while we address the repairs need on the Town's engine.
- The Police Department has hired Brieanna Murphy on a part time basis with the hopes of full time employment down the road.
- A conditional offer has been made to a new officer who would attend the Police Academy in Feb. of 2024.
- Officer McKendrick Johnson is scheduled to graduate the Police Academy in December.
- Chief Tim Page's last day is November 30th.
- Budget development is currently a priority in the Town Manager's Office. Expecting to have a public presentation at the second meeting in December.
- The Knob Property Committee has completed and submitted an application for a VOREC Grant. Chad thanked the committee for all the hard work that went into completing the grant application.
- Joe Kasprzak, Assistant Town Manager had nothing to report.
- Dennis asked if Chad had a chance to check on the Calex Contract and the increase for 2024. Chad said he has sent it over to legal for an opinion.
- Steve Isham mentioned that the second Select Board meeting for December is scheduled for Dec. 25th. He inquired about moving it to another day that week. Chad recommended Wednesday Dec 27th as nothing else was scheduled in the Welcome Center during that time. The board was good with moving the meeting to Dec. 27th.
