ARTICLE I

Shall general obligation bonds of the Town of St. Johnsbury in an amount not to exceed Three Million Seven Hundred Eighty-One Thousand Eight Hundred Seventy-Three Dollars (\$3,781,873), which is in addition to the \$5,400,000 of indebtedness approved at a special meeting of the Town on September 14, 2021, such additional indebtedness being subject to reduction from available state and federal grants-in-aid, be issued for the purpose of financing the cost of making public improvements, namely, acquisition, reconstruction, renovation and conversion of the former Armory for use as a public safety building, the aggregate estimated total cost of such improvements being Twelve Million Five Hundred Fifty-Eight Thousand Eight Hundred Seventy-Three Dollars \$12,558,873.00.
